**Rules and Regulations Governing the
2020 CHRISTMAS PARADE**

The following rules are promulgated for the orderly control of the parade and with the specific goal of providing for the entertainment of the people:

1. Participants shall include any pageant winner, political official, group or organization, manufacturers, retailers, religious groups, civic and community groups, military, school or entertainment groups. However, any group or organization must have been in existence for six (6) months prior to application.
2. Participants in the parade should be allowed to advertise to the extent of signs and handbills showing their identity, groups or affiliations, items manufactured (excluding price) and other related matters to identify the participant: However participant will in no way be allowed to deliver a message or advertisement except to the extent set out above.
3. No person, group, organization, or any member of the parade will be allowed to stop along the parade route unless directed by the chairman of the parade or his duly-appointed subordinates. Distance between units shall not exceed 100 to 300 feet. Disregard of this rule shall result in disqualification from judging or removal from the parade. Decision of the Parade Chairman is final.
4. Any animal or group of animals shall be required to have a clean-up crew immediately following the animal or group of animals.
5. Any special event such as helicopter rides, balloon ascensions, eating contests, plays, sports tournaments, etc., shall be able to advertise the time, place and admission price of such an event in the parade provided such event is sanctioned by the Spring City Chamber of Commerce.
6. Qualifying participants wishing to participate in the parade shall apply at the Chamber of Commerce in Spring City, Tennessee, no later than 3:00 p.m. on Thursday, December 3, 2020. An application fee of \$20.00 will be payable for each entry or entry group competing as one unit. A Unit is up to 3 vehicles or horses.
7. No article such as candy, etc. shall be thrown into the crowd along the parade route from vehicles in the parade.
8. No alcoholic beverages are allowed during the line-up or along the parade route.
9. It is understood that after each qualifying participant is accepted for parade entry, they shall be under the control of the Chairman of the Spring City Chamber of Commerce Christmas Parade, and agrees to follow his/her directions.

Every applicant shall by receipt of these rules be put on notice that they may be excluded from the parade at ANY TIME if the above rules are NOT followed and/or they do not meet the qualifying criteria for parade participation.

The Review Board will evaluate applications for final decision. Review Board decision is final.
